1. Increase in the Authorized Share Capital of the Company from INR 15,103,207,830/- (Rupees Fifteen Billion One Hundred Three Million Two Hundred Seven Thousand Eight Hundred and Thirty Only) divided into 1,510,320,783 Equity Shares of INR 10/- (Rupees Ten) each to INR 24,109,419,000/- (Rupees Twenty Four Billion One Hundred Nine Million Four Hundred Nineteen Thousand Only) divided into 2,410,941,900 Equity Shares of INR 10/- (Rupees Ten) each.
2. To issue up to 145,833,333 Equity Shares of the Company having face value of INR 10/- each, at an issue price of INR 24/- (including premium of INR 14/-) per Equity Share for an aggregate value not exceeding INR 3,499,999,992/- (Rupees Three Billion Four Hundred Ninety Nine Million Nine Hundred Ninety Nine Thousand Nine Hundred and Ninety Two Only) to Toyota Financial Services Corporation, Japan, Holding Company, by way of Preferential Issue on Private Placement basis.
